## ESSENTIAL CRITICAL INFRASTRUCTURE WORKER Authorization of travel related to agriculture production, distribution and service

- 1. The United States Department of Homeland Security's Cybersecurity and Infrastructure Security Agency (CISA) designates the food and agriculture sector as a critical infrastructure sector whose assets, systems, and networks are considered so vital that their incapacitation or destruction would have a debilitating effect on security, national economic security, national public health, or safety.
- 2. The President's Coronavirus Guidance published on March 16, 2020 (available at <a href="https://www.whitehouse.gov/briefings-statements/coronavirus-guidelines-america/">https://www.whitehouse.gov/briefings-statements/coronavirus-guidelines-america/</a>) instructs employees of Critical Infrastructure Industries, such as the food and agriculture sector, to maintain normal work patterns during the global coronavirus outbreak. On March 19, 2020 the Department of Homeland Security identified the specific industries that comprise Critical Infrastructure Industries (available at <a href="https://www.cisa.gov/publication/guidance-essential-critical-infrastructure-workforce">https://www.cisa.gov/publication/guidance-essential-critical-infrastructure-workforce</a>).
- 3. The Governor's Executive Order No. GA-11 issued on March 26, 2020 (available at <a href="https://gov.texas.gov/news/post/governor-abbott-issues-executive-order-mandating-14-day-quarantine-for-travelers-arriving-from-new-york-tri-state-area-new-orleans2">https://gov.texas.gov/news/post/governor-abbott-issues-executive-order-mandating-14-day-quarantine-for-travelers-arriving-from-new-york-tri-state-area-new-orleans2</a>) instructs that any quarantine order is inapplicable to commercial traffic crossing state lines that is critical infrastructure. Critical infrastructure includes agricultural production and distribution as well as employees engaged in the service, transportation or manufacture related thereto and the maintenance of equipment related to such production and distribution.
- 4. This document certifies that the bearer is an agricultural worker and/or food production worker involved in the production of field crops, the manufacture of human food and/or the distribution of agricultural products and other human food through wholesale, retail, auction, market and/or foodservice distribution within a sector; and/or a worker involved in horticulture, including floristry, that has been designated as critical infrastructure, the continued operation of which is vital for security, national economic security, national public health, and safety.
- 5. Accordingly, it is appropriate, considering the President of the United States Coronavirus Guidance to allow this worker to proceed unimpeded to and from their place of employ in the state and federal interests of protecting the nation's food supply chain.
